### Art In My Back Yard's Second Exhibit A Hit!

On Friday, November 14th, the Art in My Back Yard artistic series opened its second exhibit, titled *Mortal*, a contemplation of death and rebirth. More than 150 art lovers gathered the evening of the opening to sip wine and appreciate the works of the three artists chosen by the AIMBY exhibition committee. The show of painting, ceramics and sculpture by **Mel Dean Westmeyer**, **Chris Busse** and **David Dumo** offered both sober and playful takes on the theme of mortality.

The setting was a storefront space at 3959 W. Irving Park Rd., rented for four weeks by the West Walker Civic Association. Under the direction of West Walker artist **Jackie Kazarian**, the former comic book store was transformed into an impressive gallery space.

In addition to the opening, AIMBY sponsored several free events during the month-long exhibit. Artists Chris Busse and Mel Westmeyer spoke eloquently about their works in an artists talk, 14 neighborhood children created their own found object shadow boxes in a kids' workshop, and an artist's networking event was held featuring Jackie Kazarian and **Anne Mills** of the Around the Coyote Festival in Bucktown.

### **CAPS** Report

New issued raised:

- In the past, there have been noise complaints outside a business between Springfield and Pulaski on Montrose during closing time. Police had talked to the owner and things quieted down. A citizen asked Police to revisit in an effort to maintain the continual noise reductions.
- Citizens stated there is an effort under way to get the liquor store at the corner of Irving Park and Elston to stop selling malt liquor. The citizens believe the selling of malt liquor attracts the wrong element to the neighborhood.
- This month, there were two arrests in the Independence Library. This was due to alleged public disturbances outside with the alleged assailants running into the Library. Citizens asked if the Police could heighten their presence when kids are released from school.
- Officers stressed the importance of reporting disturbances to 311. Each call is assigned a tracking number. Citizens can then track the status of the calls made on the 311 website.
- The January Caps' meeting will feature a speaker on the prevention of auto theft.

### Update on The Stripp Joynt

This article was compiled from reports by area residents and documents acquired from the Dept. of Administrative Hearings.

Note: This company has, apparently, shortened its name. It originally opened as the Stripp Joynt of Evanston, LLC in 2007. During the summer of 2008 it became The Stripp Joynt.

Last year on November 14, 2007, The Stripp Joynt at 4172-76 N. Elston Ave. was allowed to resume stripping paint and spraying finishes by signing an Agreed Administrative Order with the City of Chicago Department of Environment regarding maintenance and safety. This was required after a fire occurred at the facility on August 30, 2007. Since November 14, 2007, area residents have made numerous complaints to the Department of Environment and the 39th Ward office about strong chemical odors coming from this business.

On May 12, 2008, The Stripp Joynt of Evanston, LLC, received a ticket for violating **City Ordinance 7-28-080 Nuisance in connection with business**. The ticket was issued by the Dept. of Environment and states: "Respondent caused odor nuisance by not properly maintaining its spray booth." A separate report by the environmental engineer who wrote the ticket states three violations of the Agreed Administrative Order with the City of Chicago Dept. of Environment were found: "1) Stripping of doors was being done outside the stripping tank. 2) Spray booth filters were laden with particulate matter. I tapped on one of the filters and cakes of dust cascaded down to the floor. 3) Pressure gauge was functional but was not used as an indicator of when to change filters in the booth." The ticket required the owner to make a mandatory appearance for an Administrative Hearing on June 19, 2008, at 400 W. Superior St. On that date, the owner appeared and made a motion for a continuance, which was granted. A new hearing date was set for August 14, 2008.

Meanwhile, on July 14, 2008, The Stripp Joynt received another ticket from the Dept. of Environment for violating two city ordinances, **7-28-080 Nuisance in connection with business and 11-4-630 Atmospheric pollution prohibited**. The ticket states: "Respondent caused or allowed noxious organic odors to pollute atmosphere. Respondent caused a health nuisance with release of noxious organic odors." Excerpts from the report of the environmental engineer who issued the ticket state: "Upon arrival to the site I immediately detected strong, foul paint and lacquer chemical odor along Avers St. At this time, my eyes began to tear up and slight burning sensation was felt in my nose ... The entire atmosphere along Avers Ave. was saturated with paint and lacquer chemical odors. The odors detected were excessively noxious." This ticket required the owner to make a mandatory appearance for an Administrative Hearing on August 28, 2008.

On August 14, 2008, the continued hearing for the first ticket of May 12, 2008, was held. The owner appeared and pleaded liable. A "liable plea" is the term used for a guilty plea in the administrative hearing system. He was fined \$400 plus court costs.

The hearing for the second ticket of July 14, 2008, took place on August 28, 2008. The owner appeared and made a motion for a continuance, stating that he needed time to get a lawyer. The motion was granted and a new hearing date of October 23, 2008, was set. On October 22, 2008, neighbors were notified that they would be needed to testify at the hearing. Three area residents were able to attend and they met with a city attorney before the hearing was to begin. However, the owner of the Stripp Joynt failed to appear and no attorney was there to represent him. Therefore, testimony from residents was not needed. The Dept. of Administrative Hearings found him liable by default and ordered the maximum fine on each of the two counts, a total of \$2,000 plus court costs. On October 30, 2008, the owner of the Stripp Joynt filed a Motion to Set-Aside Default. Such motions are allowed if made within 21 days of the default and a good cause for missing the hearing is stated under oath. The owner's reason was "Did not receive notice." A new date of November 20, 2008, was set to hear the motion and, if it was accepted, to have an immediate hearing on the violations. The owner appeared on November 20, 2008, without an attorney. The Motion to Set-Aside Default was granted, and he subsequently pleaded liable to both counts. He was ordered to pay a fine of \$500 for each count, a total of \$1,000 plus court costs.

In early September 2008, the Stripp Joynt replaced the exhaust stack on the roof of their building with one that is more than twice the height of the old stack. Residents near this business have been affected by chemical odors since it was installed and it may also cause odors to be dispersed to other areas of the neighborhood.

# <u> Office Report: 3</u>

Are you entitled to a refund on your property taxes? You may be, if you haven't been taking all the exemptions to which you are eligible. Currently, you can still file for refunds on your 2007, 2006, 2005 and 2004 taxes.

Take a look at your Second Installment tax bills to see what exemptions you have received. The right side of the bill lists different kinds of exemptions, and if you received the exemption, it will show how much it saved you. If you received the Long-Time Homeowners Exemption, the Disabled Persons' Homeowners' Exemption, the Disabled Veterans' Homeowners' Exemption, or the Returning Veterans' Homeowners' Exemption, there will be an asterisk next to the Homeowners' Exemption line.

Here are the main exemptions:

- Homeowners' Exemption
- Senior Exemption (65 or older)
- Senior Freeze
- Long-Time Homeowners' Exemption (for those who have owned their homes ten years or more)
- Disabled Persons Homeowners' Exemption
- Disabled Veterans Homeowners' Exemption
- Returning Veterans Homeowners' Exemption

Note that you cannot take both the Senior Freeze and the Longtime Homeowners' Exemption. If you qualify for both, the Senior Freeze is generally the better deal. Also, the Longtime Homeowners' Exemption, the Disabled Persons Homeowners' Exemption, the Disabled Veterans Homeowners' Exemption and the Returning Veterans Homeowners' Exemption are new to the 2007 property tax code.
