Citizens and Politicians Seek Solutions to Quiet the Skies

About 50 neighbors came out to learn what is being done about the increased air traffic and noise resulting from the O'Hare Modernization Plan (OMP). The OMP calls for decommissioning two north/south diagonal runways and directing flights over new and existing east/west runways.

in Runways, stated that as a result of the OMP, 70% of daytime and 85% of nighttime arrivals come from the east. Neighbors are experiencing a dramatic increase in air traffic and noise with the opening of the Wilson runway in October 2013. In August, the Chicago Department of Aviation reported that the new Wilson runway had 458 flights per day of which 274 flights were arrivals from the east. Wilson had the most night time arrivals in August averaging 43 per day. Neighbors will be further impacted by air traffic and noise when the new Berteau runway opens in September 2015. FAIR seeks a more equitable allocation of flights to all runways including the 2 north/south diagonal runways.

Congressman Quigley talked about federal efforts including spearheading the Quiet Skies congressional caucus seeking solutions for airplane noise.

Current efforts include changing the noise metric from 65DNL (Day-Night Average Sound Level) to 55DNL so more homes will qualify for sound proofing. Congressman Quigley said we need fair distribution of runways, public hearings about the OMP and a better online complaint system. He is sponsoring a bill to phase out loud planes and is working with the FAA to keep all runways open. The Congressman feels diagonal runways help improve the efficiency of O'Hare, particularly with wind changes. He hopes to have a plan in place by spring and suggested citizens write letters to the Chicago Department of Aviation and the FAA in support.

Alderman Laurino, 39th Ward, said she supports FAIR. She lives under the flight path of the 27L (Thorndale) runway. "We did not move by the airport, the airport moved to us." Alderman Laurino is sponsoring a referendum on the November ballot asking the FAA to revisit the criteria for noise mitigation and soundproofing. American Airlines and United Airlines represent about 80% of flights into O'Hare and she is in conversations with these airlines to expedite retirement of the noisy MD80 aircraft.

Lastly, Alderman Arena, 45th Ward, spoke about being part of the O'Hare Noise Compatibility Commission (ONCC) - An inter-governmental agency seeking solutions to airplane noise. The Alderman feels he can have the biggest impact as part of the ONCC technical committee. Where can we fight the FAA? He suggested changing the glide path from the current 3 degrees to 4 degrees. Planes would then be higher in the sky over more of the city.

Both Aldermen are working to place additional noise monitors in our neighborhoods to track flight noise.

Write the Mayor, the Chicago Department of Aviation and the FAA. We can make a difference.

MY HOME APPRAISAL WAS LOW. WHAT CAN I DO?

If you're thinking of buying a home or refinancing your current home, you will need an appraisal.

It's an estimate of market value by a licensed Appraiser. Square feet, home condition, number of bedrooms and baths, finished basement, garage...all factor into the value. The Appraiser compares your home to comparable sold homes in the area; increases or decreases that home value based on these factors and then determines your home value.

If you are the Buyer and the appraisal comes in low, you can ask the seller to lower the agreed price; add more to your downpayment; ask for a 2nd appraisal with a different Appraiser or apply with a different lender. It's very possible 2 different Appraisers will give 2 different values. A lot depends on how well the Appraiser knows the neighborhood. Have your Realtor provide recent sales to the Appraiser. Also look for property detail errors on the report.

If you are looking to refinance, you can contest the appraisal by providing recent sales; bring money – a cash-in refinance – if you want to lower your interest rate; or start over with a different lender.

Appraisals are an art and a science. The art reflects the recent sales the Appraiser uses to compare your home to and how well he knows the neighborhood.

I will continue to share your concerns and ideas with the Mayor, his staff, and the Department of Aviation. It was also nice to see many West Walker residents at

the Wintrust First Chicago Bank grand opening. If you haven't been to their new branch at 4343 N. Elston, stop by. I expect them to be a good neighbor and a strong supporter of the West Walker community.

One of the best ways to prevent the flu is to get a flu shot. The Chicago Dept. of Public Health (CDPH) has collaborated with Aldermanic offices to host immunization events where residents can get a free flu shot. My 39th Ward office (4404 W. Lawrence) is hosting our annual flu shot day on Friday, November 14, from 10a.m. – 2 p.m. If you can't make it to my office, CDPH has a map that shows other locations offering flu shots.

Autumn is here and that means leaves are falling. If leaves fall on the parkway in front of your home or on your property, you are responsible for their removal (burning is not permitted). Please rake and bag the leaves. Do not rake the leaves into the street, it results in clogged water drains and street sweeper trucks. When drain gates are blocked rain water, melting ice and snow cannot be drained from the street

Don't forget - On Sunday, December 1, 2014, Chicago reactivates its Winter Overnight Parking Ban for the most critical arterial streets. Signs for this seasonal restriction are permanently posted. Cars parked on arterial streets with a posted seasonal overnight restriction will be ticketed and towed between the hours of 3:00 a.m. and 7:00 a.m., whether or not there is snow on the ground. This restriction is in effect until April 1.

Three Brothers Garden Produces 840 lbs. of Vegetables in Successful Season

With one more harvest planned, Three Brothers Garden expects to close the 2014 growing season with a whopping yield of more than 840 lbs. of vegetables. Now in its sixth year of operation, the garden is a partnership between Carlson Community Services and Irving Park Lutheran Church. Vegetables grown in Three Brothers Garden are distributed to clients of the Irving Park Community Food Pantry. This past season we grew radishes, lettuces, greens, carrots, squash, peppers, cucumbers, tomatoes, beets, herbs and green beans. In planning what to grow, the volunteer committee that oversees the garden considers nutritional value and ease of preparation for food pantry clients.

Volunteers began working in the garden in mid-April and gardened through late October. Nearly 250 volunteer hours were logged, including harvesting, planting, clean-up and watering. Between 8 and 10 volunteers participated each week in the Tuesday night harvests. Regular volunteers included Melanie Reschke, Martha Sanders, Judy Madsen, Dorene Jordan, Darcie Wadycki, Rebecca and Elmer Haneberg, Ellen and Ron Olech, Ruth Olech and Erin Bouman. Volunteers were led by college intern Matt Wylder. Matt oversaw the weekly harvests, delivered vegetables to the food pantry and tracked the number of hours volunteers worked and pounds of vegetables grown.

Ruth Olech and Rebecca Haneberg are the co-chairs of the volunteer committee that oversees the garden. Committee members are Erin Bouman, Yaz Ebeid, Dorene Jordan, Liz Mills, Melanie Reschke and Rich Wielock. The garden is fortunate to have such talented and dedicated garden leaders and volunteers! Pantry Prepares for Holiday Distributions

We're building up stores for two holiday distributions, in November and on December 17th. We ask for contributions of funds, food and fun (i.e., books and toys) to help make the season brighter for those in our community who can use a hand during the holidays.

In November, we provide clients during our regular weekly distributions with additional meat and trimmings for a Thanksgiving dinner. December 17th will be a special holiday distribution at which we give clients the makings for a full holiday dinner. Clients will also select a gift for each of their children from the toy room.

For these special distributions, we are in need of juice, stuffing, cranberry sauce, canned yams and vegetables, instant potatoes, cake mixes, Jell-O and pumpkin-pie filling. In addition, we need dry goods, such as peanut butter, macaroni & cheese, hamburger helper-type meals (rice-aroni, pasta-roni), whole-grain crackers, dried fruit and nuts, dry soup mixes, energy bars and juice (100% fruit juice). We always need toiletries and white crew socks.

About 400 children (ages infant to 12) are given a gift in this distribution. For some, it will be the only gift they receive. We especially need gifts for older children (age 10 to 12), especially boys, as we receive far fewer for that age group. **Unwrapped, new** toys and food donations can be brought to the Pantry at the Irving Park United Methodist Church (3801 N.
