Thinking of Appealing Your Property Taxes?

Last year homes in our neighborhood, in Jefferson Township, were reassessed (in 2018 for taxes payable in 2019). Even though this isn't an assessment year, you can still appeal your taxes and here are the steps.

- **1. Appeal to the Cook County Assessor** during the 30 days when Jefferson Township is open to appeals. 2020 dates are not published yet but are likely similar to 2019 dates 8.8.19 until 9.6.19. Go to cookcountyassessor.com to find forms and check appeal dates.
- **2.** Appeal to the Cook County Board of Review (CCBR) which is independent of the Assessor. Even if you received a reduction from the Assessor, you can still file here appeals.cookcountyboardofreview.com for info. 2020 dates to file are TBD. 2019 dates were 12.2.19 until 12.31.19.
- **3.** Appeal to Illinois Property Tax Appeal Board (PTAB) if you appealed to CCBR above #2, you can further appeal to PTAB with 30 days of CCBR's decision. For more info go to www.ptabillinois.gov.

There are specific rules and deadlines so you may want to verify dates and contact an attorney. Feel free to call or email for attorney recommendations.

CAPS Report

Beats 1722 & 1723 February 19, 2020

In attendance: 17th District Commander Ronald Pontecore, Jr, CAPS Officer Jerry Zander, Lt. Michelene Alexa, Beat Officers, Alderman Ramirez Rosa (35th Ward), Alderman Samantha Nugent (39th Ward), and approximately 40 residents. Commander Pontecore noted that there had been an uptick in robberies, although arrests and clearance had also improved. Also discussed was the uptick in shots fired, particularly in the Montrose and Kimball area, but again, numerous arrests and leads have been developed. The general uptick in crime on public transit was also discussed, and individuals were encouraged to utilize increased vigilance when using publaic transit.

It was noted that the gang dynamics in the Montrose Kimball area was highly unusual, with individuals involved squatting within apartments rather than hanging out of street corners. Commander Pontecore stated that the 17th was fully staffed, although he agreed he would never turn down additional officers. Despite the recent focal upticks, it was again noted that overall, crime statistics were down over the past 5 years. However, the isolated upticks are being aggressively addressed. Moving forward, it was noted that the camera designated for Cullom and St Louis has been installed and that the camera to be placed in the alley behind the Russell family's house had been surveyed and installation will take place as soon as possible. Longterm, the Commander indicated that the district has been investigating investment in the Shotspotter Technology, which would drastically reduce response time to shots fired and improve location triangulation. Alderman Nugent suggested that citizens call the Mayor's office directly at 312-744-3300 and ask for the Public Safety Liaison to request additional resources and staffing for the 17th district.

Call 911 to report suspicious activity or individuals in your neighborhood and provide detailed descriptions of the individuals and vehicles involved in any incident. Even if a neighbor has already reported the incident or activity, other neighbors should make separate calls. The police often look at the number of calls for service in

CENSUS 101: WHAT YOU NEED TO KNOW

The 2020 Census is closer than you think! Here's a quick refresher of what it is and why it's essential that everyone is counted.

Everyone counts.

The census counts every person living in the United States once, only once, and in the right place.




It's in the Constitution.

The U.S. Constitution mandates that everyone in the country be counted every 10 years. The first census was in 1790.

It's about fair representation.


Every 10 years, the results of the census are used to reapportion the House of Representatives, determining how many seats each state gets.



It's about \$675 billion.

Article 1

Section 2



The distribution of more than \$675 billion in federal funds, grants, and support to states, counties, and communities are based on census data.

That money is spent on schools, hospitals, roads, public works, and other vital programs.



It's about redistricting.

After each decade's census, state officials redraw the boundaries of the congressional and state legislative districts in their states to account for population shifts.




Completing the census is mandatory: it's a way to participate in our democracy and say "I COUNT!"







